



## **CRITERIA FOR INCLUSION ON BANK'S APPROVED LIST OF ATTORNEYS**

### **A. The attorney must provide the following documents:**

- Written confirmation from The Bahamas Bar Association:
  - That he/she (the firm) is a Member in Good Standing.
  - That he/she (the firm) has never been subjected to disciplinary measures.
  - The date that he/she was called to The Bahamas Bar.
- Copy of current Professional Indemnity Insurance for a minimum coverage based on the total dollar value of work that can be performed, as stated under the firm.
- Current Business License.
- Two bank credit references (one must be from his/her firm's Bank.)
- Independent confirmation that he/she or the firm has had to claim on their Professional Indemnity Insurance for any legal opinion rendered. If yes, a brief summary of the matter must be provided.

### **B. Note the following conditions precedent:**

- A sole practicing attorney or firm cannot represent both the client and the bank.
- Any accounts with Commonwealth Bank Limited must be in good standing.
- Any accounts with other local banks must be in good standing.
- Attorneys for consideration in Freeport, Abaco and Spanish Wells must carry the Branch Manager's recommendation.
- The bank reserves the right to remove any attorney from our list at any time.
- The bank reserves the right to determine which attorney represents the bank on any individual transaction, notwithstanding a particular attorney may be on our list.
